# Federal Update

### Senate USDOT Budget Bill

The Senate passed a budget bill for USDOT and the FAA for FY 19, which will now need to be reconciled with the House version. It blocks funding for Federal Transit Administration policy changes to the Capital Investment Grants program after the FTA announced its intent to change the policy in a way many transit advocates felt would reduce funding available. You can see the breakdown of funding levels in this summary. And this report has a nice chart comparing the Senate and House FY 19 versions with the FY 18 budget.

## **Dept of Interior Infrastructure Needs**

Secretary of the Interior, Ryan Zinke, held a press event this week to highlight the need for investment in infrastructure on federal lands. Zinke said the National Parks are \$11.7 billion behind in needed infrastructure investment. Zinke is referring to all forms of infrastructure, not just transportation infrastructure. More
