OSHA Suspends Emergency COVID-19 Vaccination and Testing Standard

In September, the Biden Administration directed OSHA to issue an Emergency Temporary Standard ("ETS") requiring employers with one hundred or more employees to ensure their employees are either fully vaccinated or tested for COVID-19 on a weekly basis.
