### **Session is back! (Kind of)**

Like Jordan in the late 1995, session is coming back and similar to Jordan wearing the number 45, this session week is going to be weird. Both the House and the Senate are going to meet Wednesday-Friday. The Senate will meet in the capitol, but the House will meet at the Bank of Springfield Convention Center. All elected officials will agree to additional screening procedures

and will be largely separated from the public. Lobbyist activity will be greatly restricted.

Senate President Harmon and Speaker Madigan have indicated this will be a "special session" which will formally limit it to the consideration of the following topics:

- The COVID-19 pandemic or other disasters;
- The state budget and its implementation;
- Economic recovery, infrastructure projects, and funding thereof;
- The explanation, arguments for and against the Progressive Income Tax;
- Laws or authority scheduled to sunset prior to June 1, 2021;
- The 2020 General Election and the State Board of Elections; and
- The hospital assessment program

### **Legislative Updates**

The following legislation was filed, or action was taken in the last two weeks. As always, your input on these measures is very much appreciated:

**HB 5769 (Thapedi)** - Creates the Personal Protective Equipment Responsibility Act. Requires an employer designated as an essential employer under a disaster proclamation issued pursuant to the Illinois Emergency Management Act or an executive order issued pursuant to the disaster proclamation to provide personal protective equipment to independent contractors and to all employees during the duration of the disaster proclamation or executive order. Defines terms. Authorizes the recovery of damages, including punitive damages, and attorney's fees. Effective immediately. **The Chamber opposes this legislation and is working with the sponsor to develop something more workable.**

### **Illinois Directs \$25 Million to Speed Grants for Infrastructure**

The Illinois Department of Commerce and Economic Opportunity recently announced that \$25 million in grant funding will be used to accelerate work on planned infrastructure projects. These grants, called Fast-Track Public

Infrastructure Grants, will support local projects that are ready for construction to start this summer. Projects must be ready to begin construction within 90 days of receiving an award notice. They must be permanent public assets without recurring project expenses. Examples given were expanding water and sewer systems and modernizing schools or other public buildings. Funding for the grants come from the historic Rebuild Illinois capitol program supported by the Illinois Chamber. You can apply for the grants

Most recently, Keith was successful in lobbying the Illinois Department of Revenue to make favorable changes for Chamber members to the proposed rules on the Data Center Tax exemption and the new Illinois Parking Tax.
